Sir,

This has reference to NBA's letter of even number dated 19-01-2018 under which some of PG Engineering programs offered by your institution were granted provisional accreditation for 2 years upto 30-06-2019 in Tier-II by National Board of Accreditation.

2. National Board of Accreditation (NBA) has decided that in all cases where PG Engineering programs of an Institution were granted provisional accreditation for a period of 2 years, the period of accreditation of these programs shall be extended from 2 to 3 years subject to the condition that they meet the essential Pre-visit qualifiers. The Pre-visit qualifiers submitted by **Heritage Institute of Technology, Chowbaga Road, Anandapur P.O. –East Township, Kolkata- 700 107, West Bengal** have been considered. The following PG Engineering program(s) meet all the parameters of pre-qualifiers. Accordingly, the competent authority in NBA has approved the following accreditation status to the program(s) as given in the Table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.



If such an instance comes to NBA's notice, this will be viewed seriously. Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

6. The accreditation status awarded to the programs as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
