Pal that apart from NIT Durgapur, he had a brief stint at IIT Bombay and not at IIT Kharagpur. DTE pointed out that in the minutes it should be explicitly mentioned that Teaching Assistantship was provided to 1st year and 2nd year M.Tech. students. These were incorporated and then the minutes were confirmed.

Agenda No. 4: To consider a report on various activities of the Institute since the last meeting

The BOG noted and approved the activities of the Institute during the period under report.

The BOG expressed satisfaction that the period of validity for accreditation in respect of B.Tech. in CSE had been revised from 2 (two) years to 5 (five) years w.e.f. 04-02-2014 in response to appeal submitted to NBA.

The BOG appreciated the views expressed by the UGC Expert Committee on Autonomy during the Exit Meeting. Regarding the suggestions made by the Expert Committee, the Chairman suggested that emphasis should be given on Faculty and Staff related issues. The Member Secretary explained the following actions that had already been taken in this regard, which the BOG noted and approved.

- Application for NBA / NAAC: Process already initiated by concerned departments for submission of applications to NBA for accreditation of eligible M.Tech. programmes first, followed by preparation for NAAC.
 - In this context, DTE West Bengal pointed out that accreditation of technical colleges by NAAC / NBA had been made mandatory by UGC in terms of the latest notification.
- QIP: A policy for sponsoring members of faculty for pursuing Ph.D. under QIP would be evolved and placed before the BOG in its next meeting for consideration.
- O Budget for research: It was decided that some provisions to allocate certain percentage for research would be made during preparation of the Annual Budget. In this context, the Chairman suggested that such an allocation should be based not arbitrarily but on receiving a specific proposal from the Member Secretary. The DTE, West Bengal further suggested that members of faculty eligible to bring funds from outside might be provided matching grant from the Institute as an incentive and this might be taken into consideration during fund allocation.

- Medical Insurance: A possibility for introducing a Group Medical Insurance for members of faculty and staff was being explored and the report would be placed before the BOG in its next meeting. In this context, the Chairman pointed out that the report should also include the scope of the Institute to act as a facilitator for insurance of students' Laptops / Mobiles at a nominal cost to be borne by the students.
- o Career Advancement Scheme:

-- For members of faculty:

In response to a query made by DTE, West Bengal regarding status of implementation of CAS for members of faculty, it was reported that in absence of certain clarifications by the AICTE, the relevant order could not be implemented, although all the regular erstwhile Lecturers were re-designated as Assistant Professors in terms of the said AICTE notification. However, since UGC guidelines in this regard were clear, it was decided that CAS would be implemented accordingly on acquiring autonomous status

-- For members of staff other than faculty:

The BOG noted that promotion in this category was being accorded to deserving members on a case-to-case basis depending on their performance. In this context, the WBUT nominee pointed out that unless there was a policy, there would be scope for discrimination. It was then decided that a uniform policy for promotion of various categories of staff other than faculty would be formulated and placed before the next meeting of BOG, for consideration and approval on acquiring autonomous status.

Regarding implementation of autonomy it was discussed that as per UGC guideline, the following 4 (four) Statutory Bodies would be required to be constituted:

- (i) Governing Body / Board of Governors
- (ii) Academic Council
- (iii) Board of Studies
- (iv) Finance Committee

As per new guideline of the UGC, the BOG would have to be reconstituted for which the Principal, as the Member Secretary of the BOG was empowered to write to appropriate authorities for sending nominations. It was further resolved that other statutory bodies would be duly formed and placed before the newly constituted BOG for consideration and approval. In this context, the Chairman suggested that the Member Secretary should go ahead, in the mean time, to observe all other formalities as required for smooth implementation of autonomy.

Regarding reporting of University Examination results, the Chairman suggested that an analysis should be made at the Institutional Level to make a comparative analysis with other institutions and reported to the BOG. The difficulty in making such an analysis because of problem of having access to results of other institutions affiliated to WBUT was pointed out by the Member Secretary. However, he said that he would refer the matter to the Academic Council, once constituted.

The BOG appreciated that the Institute entered into a MOU with Sun Oil Company Pvt. Ltd. (SOC) for bridging the Industry and the Academia as an Industry-Institute-Interaction activity and conduct collaborative R&D programmes on topics relevant to both the organizations. Interaction would include cooperation in a variety of activities such as:

- Formation of a Joint Technical Team for the proposed R&D area
- Laboratory Development works and Plant level testing and applications
- Code of practice and intellectual property right
- o Organizing conferences, symposia and seminars
- Summer training and project work for engineering students of the Institute at SOC
- o Any other collaborative efforts deemed fit from time to time.

The BOG also expressed satisfaction in respect of the following:

- Organizing 2 (two) International Conferences; ICAA 2014 and ICECI 2014 successfully during the month of January 2014
- o Commendable activities by the Rotaract Club.

Agenda No.5: To report on HR related matters since the last meeting

The BOG considered and approved (i) the appointment of 03 persons on the basis of recommendations of the respective Selection Committee(s) constituted for the purpose, (ii) cases of resignation/retirement of 04 persons (along with reasons for their leaving) and (iii) Career Progression in respect of 04 members of faculty since the last meeting held on 30.11.2013.
