Minutes of the 64<sup>th</sup> Meeting of the BOG held on November 20, 2021 were duly circulated. As there was no comment from the members, the minutes were confirmed unanimously.

Note of congratulations for Shri P.R. Agarwala, Chairman BOG HITK

The meeting of BOG congratulated Shri P.R. Agarwala, Chairman, Board of Governors, HIT-K on being conferred  $Padma\ Shri$ , one of the highest civilian awards by H.E. The President of India.

To consider resolutions adopted through online meetings of 32<sup>nd</sup> Academic Council and of 22<sup>nd</sup> IQAC

BOG noted and approved both the resolutions adopted by the Academic Council in its 32<sup>nd</sup> meeting and by the IQAC in its 22<sup>nd</sup> meeting respectively, both held on 23-12-2021.

Agenda Item No. 4:

To consider a report on various activities of the Institute since the last meeting

The BOG noted the following:

- 4.1 The Institute received an order from the Government of West Bengal, Department of Higher Education bearing Memo No. 89-Edn (CS)/10M-32/2021, dated 31.01.2022 to reopen the Institute from February 3, 2022 with physical presence of the students. Principal along with senior officials of the Institute conducted an Orientation Meeting with the Members of the Faculty, TAs and Staff on February 2, 2022 to discuss matter related to reopening the Institute with effect from February 3, 2022.
- 4.2 The Institute has participated in National Institutional Ranking Framework (NIRF) 2022 by Ministry of Human Resource Development, Govt. of India. The Institute submitted Report on 11-02-2022. This is a very exhaustive job that the institute has to do every year. Formats keep on changing and nature of data become more and more probing. The BOG advised that data collection and collation should happen on a daily basis in the different offices.

4.3 Being a NAAC accredited Institution, as a mandatory requirement the Institute has uploaded the Annual Quality Assurance Report (AQAR) - 2020-2021 on the portal of the National Assessment and Accreditation Council on 31.12.2021.

Prior to submission of Self Study Report (SSR) for accreditation of the Institute in Cycle 2, as a prerequisite, the Institute submitted the Institutional Information for Quality Assessment (IIQA) on the portal of NAAC on 31.12.2021 and the same has been approved on 25.01.2022.

On approval of the IIQA, the Institute has uploaded the SSR on the portal of NAAC on 25.02.2022.

- 4.4 The Institute was accredited by National Board of Accreditation (NBA) for following 4(four) UG programmes for three academic years (AY 2019-2020 to AY 2021-2022).
  - B.Tech. in Applied Electronics and Instrumentation Engineering
  - B.Tech. in Biotechnology
  - B.Tech. in Chemical Engineering
  - B.Tech. in Electronics and Communication Engineering

As advised by NBA vide their email dated 14.01.2022, the Institute has submitted on 07.02.2022 Compliance Reports for all these programmes for further accreditation by NBA.

- 4.5 The institute has introduced two new UG courses during the AY 2021-2022 namely
  - 1. B.Tech. in Computer Science & Engineering (Artificial Intelligence & Machine Learning)
  - 2. B.Tech. in Computer Science & Engineering (Data Science)

Above two courses are now looked after under the CSE department. Considering the AICTE guidelines, it is now proposed to consider the introduction of 2 (two) new Academic Departments namely

- i) Department of Artificial Intelligence & Machine Learning
- ii) Department of Data Science
- 4.6 The Institute is taking concrete steps to implement the provisions CHAIRMAN'S of New Education Policy in a phased manner.
